- Ukraine remains the main battleground for democracy, the issue of Ukraine's
  victory is fundamental for survival of democratic way of life for the rest of
  the world, in particular in view of the recent attacks and threats, coming from
- anti-democratic regimes worldwide;
- in its atrocious and unjustified war against Ukraine, Russia aims at destroying
  the existing rules-based order by creating security, food, energy crises,
  unfolding massive misinformation campaigns, and supporting other terrorist
  regimes;
- the Ukrainian Peace Formula, presented on November 15, 2022, by President of
  Ukraine Volodymyr Zelenskyy at the Group of Twenty (G20) Summit in Indonesia,
  remains the most supported and realistic plan for achieving a just and lasting
  peace in Ukraine, as well as an effective algorithm for providing security
  guarantees and preventing aggression in the future, including against other
  countries;
- the UN General Assembly Resolution "Principles of the Charter of the United
  Nations underlying a comprehensive, just and lasting peace in Ukraine" ES-11/6
  of February 23, 2023 de-facto based upon the points of the Ukrainian Peace
  Formula was supported by 141 states;
- as of September 2023, more than 70 countries have publicly expressed their
  support for the Ukrainian Peace Formula as a whole, joined the implementation of
  its points and/or the activities of relevant working groups;
- currently Canada is gathering comprehensive support for the bill S-278 enable
  Canada to seize and repurpose Russian state assets. This enactment amends the
  Special Economic Measures Act to allow the Governor in Council to dispose of a
  foreign state's assets seized under the Act if the seizure occurred without a
  judicial order;
- approximately \$500 billion of Russian state and private assets are held in the US, Canada, the UK, and the EU member states.

## Believes that:

Ukraine's full membership in the EU and NATO is essential to ensure long-lasting
 stability in the region as well as security for the EU and NATO countries
 themselves;



- Ukrainian Peace Formula shall be the basis for any peace initiatives and it is
  essential to continue the dialogue on the implementation of the Formula at all
  levels for these efforts to result in the inaugural Global Peace Summit at the
  level of State leaders, which will adopt the Roadmap for the implementation of
  the Formula;
- Considering continuing attacks against Ukrainian civilian infrastructure by the
  terrorist troops of the Russian regime, the upcoming winter season requires
  mobilization of efforts to assist Ukraine by all possible means.

## 47 Calls for:

- intensifying efforts to ensure full-fledged membership of Ukraine in the EU and NATO in as quick and smooth way as only possible;
- supporting the Ukrainian Peace Formula as a whole and its particular points, notably on security guarantees for Ukraine;
- coordinating efforts to ensure further full implementation of the Formula that will lead to a just and lasting peace in the region and throughout the world;
- providing Ukraine with the necessary urgent and long-term military assistance to allow the country to win this war as soon as possible;
- delivering urgently new assistance packages, in particular consisting of F-16
  fighter jets, the most advanced anti-missiles and air defense systems, needed to
  protect the energy infrastructure, which suffered immensely from Russian rockets
  last winter, and was restored with great international assistance;
- protecting the transport routes and infrastructure used for transporting food
  supplies from Ukraine, which can also be achieved by additional supplies of
  advanced air defense systems, but also by increasing cooperation in the Black
  Sea region in particular;
- EU member states to introduce a 'collective countermeasure' into national legislations allowing for confiscation of Russian state-owned assets and sanctioned oligarchs' assets;
- support national governments' arguments confirming international and national legality of confiscation measures to enforce the aggressor's duty to provide;
- Tackle the destructive misuse of vetoes by revisiting the range of decisions requiring unanimity in the European Council.
